The Members,

Your Directors have pleasure in presenting the 3rd Annual Report on the performance of the Company for the financial year ended on 31st March, 2018 along with Audited Financial Statements and Auditor's Report thereon.

OPERATIONAL ACTIVITIES

Your Company was incorporated on June 30, 2015 as a wholly owned subsidiary of Power Finance Corporation Limited for holding the land and coal clock of Bihar Ultra Mega Power Project (UMPP) in the State of Jharkhand.

Under the Guidelines issued by MoP, the Company would be transferred to Procurers of power from the UMPP.

FINANCIAL REVIEW

During the year under review, your Company has not started its commercial activities. However, during the year, the Company has spent an amount of ₹10.84 Lakhs towards the Audit Fee, Legal and professional charges etc. which has been transferred to capital work in progress. The total expenditure incurred by the Company till 31st March, 2018 is ₹25.25 Lakhs.

DIVIDEND

As the Company has not started its commercial activities, your Directors have decided not to recommend any dividend for the financial year 2017-18.

SHARE CAPITAL

The paid-up share capital of the Company is ₹5,00,000/- (50,000 equity shares of ₹10/- each) as on 31st March, 2018. During the year, the entire share capital of the Company is held by Power Finance Corporation Limited (PFC) and its nominees.

DETAILS OF SUBSIDIARY/JOINT VENTURES/ASSOCIATE COMPANIES

There are no Subsidiary/ Joint Venture/Associate Companies within the meaning of Section 2(87) and Section 2(6) of the Companies Act, 2013.

DIRECTORS

agency for lease license of land, coal block etc. As a policy, all the expenditure incurred (including general overheads) in the process of acquiring the above infrastructure and assets are booked as capital Work in progress during the financial year. The consideration/cost of these assets forming part of CWIP will be recovered from the procurers/successful bidder of project as per applicable Government of India policy in the matter at the time of transfer of the SPV. However, no specific development activity pertaining to the project has been undertaken during the relevant financial year and also since incorporation, though costs incurred are in the nature of general overheads and interest charge by the holding company on funding proportionate levy of general overheads by the consulting company of the group. Applicable Accounting Standards require these expenses incurred during the period when no development activities for the project in hand have been undertaken be charged to the statement of profit and loss. In our opinion, this constitutes departure from the Accounting Standards referred to in section 133 of the Companies Act, 2013 and the Companies (Accounts) Rules, 2014. However, management disagreed to our opinion and was holding that as these expenses in total are recoverable in future at the time of transfer of the PS from the bidder of the project, hence the same can not be classified as loss. Management has also produced in support of their contention, copy of comment of CAG of india u/s 619(4)of the Companies Act, 1956 in case of DGEN Transmission Company Limited for the year ended 31/03/2014 vide their report dated 21/08/2014, and we quote, "the company has correctly capitalized the expenses as per para 9.2 of AS-10. These expenses are recoverable by PFC Consulting Limited from the prospective bidder to whom this company is to be transferred on selection of bidder. As such, these expenses cannot be treated as loss to the Company ." it is, however, uncertain to ascertain the amount getting recovered in future from the prospective successful bidder, uncertain to ascertain whether the expenses would be materialized in a capital asset at all and even implementation of the proposed project is uncertain at the given point of time such. Hence, the same, might be affecting the financial position of the company adversely in future.

2. The Company has charged expenses as apportioned levy though Debit Notes of M/s PFC Consulting Limited (PFCCL), submitted along with copies of common expenses of general service providers in the name of PFCCL. Company has also paid service tax on the charges levied through debit Notes of PFCCL. However, as per advice received by the Company, TDS has not been deducted from such payment, though the company may be held liable for tax at source. Moreover, for a charge to expense, proper expense bill should be the basis, which is not available with the Company. On both counts, the Company may be financially affected. We do not modify our original opinion expressed above based on these comments

These facts are already disclosed adequately in the relevant note no. 10 of "Other Notes to the financial statements". Further, in regard to TDS on allocation of expenses to the company an opinion was also taken according to which, no tax is required to be deducted on payments made to PFCCL by the Company.

RISK MANAGEMENT

The Company is a Special Purpose Vehicle (SPV), incorporated for specific project and to hold

land for power station including corridors like ash pipeline, water pipeline, fuel (coal/Pol) transportation, access roads etc. The cost of the acquisition of land would be sought from

procurers and would be deposited with State Government. The SPV will provide land on lease

for the power station, corridors and coal block as well as mining rights to the developer selected

based on competitive bidding process as per the Guidelines/SBDs issued by Ministry of Power.

As the Company will be transferred to the Procurers of power, risk management is necessary

only till such transfer takes place. However the management regularly identifies the probable

risks associated during this phase and takes adequate steps for the risk management.

In case, the project is abandoned or cannot be bid out or there is no selected developer after

carrying out bidding process, the initial expenditure incurred by PFC in formation of SPV as

share capital/other expenses and the other costs incurred on pre development activities would

be adjusted against the commitment advance received from procurers in the operating SPV $\ensuremath{\mathrm{viz}}.$

"Deoghar Mega Power Limited".

Further, in case the developer is successfully selected, then the SPV would be transferred to

Procurers of power from the Project.

An audit involves performing procedures to obtain audit evidence about the amounts and the disclosures in the Financial Statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the Financial Statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal financial control relevant to the Company's preparation of the Financial Statements that give a true and fair, view in order to design audit procedures that are appropriate in the circumstances. An audit also includes evaluating the appropriateness of the accounting policies used and the reasonableness of the accounting estimates made by the Company's Directors, as well as evaluating the overall presentation of the Financial Statements.

We believe that the audit evidences we have obtained are sufficient and appropriate to provide a basis for our audit opinion on the Financial Statements.

04. Opinion

In our opinion and to the best of our information and according to the explanations given to us, the financial statements give the information required by the Act in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India:

- (a) in the case of Balance Sheet, of the state of affairs of the Company as at 31st March, 2018;
- (b) In the case of Statement of Profit and Loss, of no profit no loss for the year ended on that date; and
- (c) In the case of Cash Flow Statement, of the cash flows for the year ended on that date.

05. Emphasis matter Paragraph

01. The company has included all expenses comprising interest, general administrative and outsourcing services cost in Capital work-in-progress (CWIP), which stands at Rs. 25,25,589 as on the Balance Sheet date. The company is a subsidiary of PFC and incorporated as a Special Purpose Vehicle (SPV) for holding licensed premises of proposed Ultra Mega Power Project in the State of Jharkhand ('the project') including Coal Block License, Coal Blocks Land, Power Plant Land and Land for Corridors for the construction, operation and maintenance of electricity system and integrated fuel system and to act as a nodal agency for lease license of land, coal blocks etc. As a policy, all the expenditure incurred (including general overheads) in the process of acquiring the above Infrastructure and assets are booked as Capital Work in Progress during the financial year. The consideration/cost of these assets forming part of CWIP will be recovered from the procurers/successful bidder of the project as per the applicable Government of India policy in the matter at the time of transfer of the SPV. However, no specific development activity pertaining to the project has been undertaken during the relevant financial year and also since incorporation, though costs incurred are in the nature of general overheads and interest charges by the holding company on funding proportionate levy of general overheads by the consulting company of the group. Applicable Accounting Standards require these expenses incurred during the period when no development activities for the project in hand have been undertaken be charged to the statement of profit and loss. In our opinion, this constitutes departure from the Accounting Standards referred to in Section 133 of the Companies Act, 2013 and the Companies (Accounts) Rules, 2014. However, management disagreed to our opinion and was holding that as these expenses in total are recoverable in future at the time of transfer of the PS from the bidder of the project, hence the same can not be

classified as loss. Management has also produced in support of their contention, copy of comments of CAG of India u/s 619(4) of the Companies Act,1956 in case of DGEN Transmission Company Limited for the year ended 31/03/2014 vide their report dated 21/08/2014, and we quote, "the company has correctly capitalized the above expenses as per Para 9.2 of AS-10. These expenses are recoverable by PFC Consulting Limited from the prospective bidder to whom this company is to be transferred on selection of bidder. As such, these expenses cannot be treated as loss to the Company." It is, however, uncertain to ascertain the amount getting recovered in future from the prospective successful bidder, uncertain to ascertain whether the expenses would be materialized in a capital asset at all and even implementation of the proposed project is uncertain at the given point of time as such. Hence, the same, might be affecting the financial position of the company adversely in future.

O2. The Company has charged expenses as apportioned levy through Debit Notes of M/s PFC Consulting Limited (PFCCL), submitted along with copies of bills of common expenses of general service providers in the name of PFCCL. Company has also paid Service tax on the charges levied through Debit Notes of PFCCL. However, as per advice received by the Company, TDS has not been deducted from such payments, though the Company may be held liable for Tax at source. Moreover, for a charge to the expense, proper expense bill should be the basis, which is not available with the Company. On both counts, the Company may be financially affected. We do not modify our original opinion expressed above based on these comments.

06. Report on Other Legal and Regulatory Requirements

1.As required by the Companies (Auditor's Report) Order, 2016("the Order"), issued by the Government of India in terms of sub-section 11 of section 143 of the Act, and on the basis of such checks of the books and records of the Company as we considered appropriate and according to the Information and explanations given to us, we give in the "Annexure-I", a statement on the matters specified in paragraphs 3 and 4 of the said Order.

Notes to the Financial Statements for the year ended March 31, 2018

1 Corporate Information

The Company was incorporated on June 30, 2015 under the Companies Act 2013 as a wholly owned subsidiary of Power Finance Corporation Limited (PFCL), a Govt, of India Undertaking. The Company is a Special Purpose Vehicle (SPV) formed as Infrastructure company for holding licensed premises of Ultra Mega Power Project in the State of Jharkhand. The Company has been incorporated to hold Coal Block License, Coal Blocks Land, Power Plant Land & Land for Corridors for the construction, operation and maintenance of electricity system and integrated fuel system and to act as a nodal agency for lease license of land, coal blocks etc. All the expenditure incurred or to be incurred (including general overheads) in the process of acquiring or holding the above Infrastructure and assets are booked as Capital Work in Progress. The consideration/cost of these assets forming part of CWIP to be recovered from the procurers/successful bidder as may be decided as per the guidelines to be Issued by the Ministry of Power, Government of India, from time to time.

2 Significant Accounting Policies

a. Basis of Preparation

The financial statements have been prepared in accordance with historical cost convention on accrual basis in accordance with the Generally Accepted Accounting Principles (GAAP) and Accounting Standards specified under Sec 133 of Companies Act, 2013 read with Rule 7 of the Companies (Accounts) Rules, 2014, and other applicable provisions of the companies act 2013.

b. Use of Estimate

The preparation of financial statements requires management to make estimates and assumptions considered in the reported amounts of assets and liabilities (including contingent liabilities), revenues and expenses of the reporting period. The difference between the actual results and estimates are recognized in the period in which the results are known and/or materialised.

c. Capital Work in Progress

Expenditures incurred on Consultancy /Administration /Interest /Manpower Charges/ Legal & Professional etc. and other expenditures during construction period are capitalized & treated as Capital Work in Progress.

d. Recognition of Income/ Expenditure

Incomes and expenses (except as stated below) are accounted for on accrual basis.

e. Preliminary Expenses

Preliminary expenses are charged to the Statement of Profit & Loss in the period in which such expenditures are incurred.

f. Borrowing Cost

Borrowing cost is charged to the Statement of Profit & Loss for the year in which it is incurred except for capital asset which is capitalized till the date of commercial use of the asset.

g. Expenditure incurred by Holding Company

Expenditure incurred by the company for the project is funded by the Holding Company (PFCL) and is considered as Long-Term Borrowings under the head Non Current Liabilities. The rate of interest charged is as applicable in PFC for the Project Loan/Schemes (Generation) for Borrowers under category "State Sector Borrowers (Category 'A') as determined from time to time.

h. Provisions, Contingent Liabilities and Assets

The Company recognizes a provision when there is a present obligation as a result of a past event that probably requires outflow of resources, which can be reliably estimated. Disclosures for a contingent liability are made without a provision in books when there is an obligation that may, but probably will not (in the opinion of the management), require outflow of resources. Contingent assets are neither recognized nor disclosed in the financial statements.

i. Cash Flow Statement

Cash flow Statement is prepared in accordance with the indirect method prescribed in Revised Accounting Standard-3 on Cash Flow Statement.

j. Cash & Cash Equivalents

Cash comprises cash in hand, demand deposits with banks, imprest with postal authorities and cheques /drafts/pay orders in hand. The Company considers cash equivalents as all short term balances (with an original maturity of three months or less from the date of acquisition), highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value.

k. Taxes

Provision for taxation includes provision for Income Tax and Deferred Tax. Current income tax is provided at the rates in force in accordance with the provisions of Income Tax Act 1961. Deferred tax is recognised, on timing difference, being the difference between taxable income and accounting income that originate in one period and are capable of reversal in one or more subsequent periods using the tax rates and laws that are enacted and are substantively enacted as on the Balance Sheet date. Where there is unabsorbed depreciation or carried forward losses, deferred tax assets are recognised only if there is virtual certainty of realisation of such assets. Other deferred tax assets are recognised only to the extent there is reasonable certainty of realisation in future.
