This is to inform that the following Special Purpose Vehicles (SPVs) Companies have been incorporated as wholly owned subsidiaries of PFC Consulting Limited (PFCCL) (a wholly owned subsidiary of Power Finance Corporation Limited (PFC)):

1.	NES DHARASHIV TRANSMISSION LIMITED	For Transmission Scheme for development of "Network Expansion scheme in Maharashtra for Evacuation of RE Power from Dharashiv, Beed District".
2.	NES NAVI MUMBAI TRANSMISSION LIMITED	For Transmission Scheme for development of "Network Expansion scheme in Maharashtra for providing supply to Data Centre Loads in Navi Mumbai".

Maharashtra State Electricity Transmission Company Limited (MSETCL) has placed Letter of Intent (LOI) dated 17.01.2025 appointed PFC Consulting Limited (PFCCL) as Bid Process Coordinator (BPC) for the purpose of selection of Transmission Service Provider (TSP) to establish the abovementioned transmission system through Tariff Based Competitive Bidding Process.

As per the provisions of tariff based competitive bidding Guidelines issued by the Ministry of Power, the BPC has to prepare the project profile and initiate the process of land acquisition and forest clearance, if required. For these activities, a Special Purpose Vehicle (SPV) is required to be incorporated which will take up various preparatory activities of the transmission projects e.g. survey and preparation of report, initialization of the process of acquisition of land and also initiate the process of seeking forest clearance, if required.

The SPV has to be transferred to the Successful Bidder selected through International Competitive Bidding Process under Tariff Based Competitive Bidding Guidelines for Transmission Service issued by Ministry of Power.

Accordingly, the above SPVs have been incorporated as a wholly owned subsidiaries of PFCCL to develop the aforementioned transmission scheme. These SPVs will be transferred to the successful bidder after the completion of the bidding process. The successful bidder selected through the bidding process would develop the project.
