## PFC inks Agreement to provide LED Street Lighting Systems for villages in Faridabad

New Delhi, 03<sup>rd</sup> March 2022, PFC, A Maharatna Company and India's leading NBFC in power sector, has signed a Memorandum of Agreement (MoA) with Municipal Corporation of Faridabad (MCF), Haryana for supply, installation and commissioning of LED Street Lighting Systems as part of its CSR initiative. MCF has already carried out the village level need assessment survey and has identified the spots and locations.
